## 4-H Member Ages



**CLOVERBUDS:** Members who are age 5, 6, 7 or 8 AND in 2nd grade  
(Kindergarten, 1st or 2nd grade)

4-H Cloverbud programs are activity, not project focused and built on the cooperative learning, rather than competitive activities.

According to state and national 4-H policy, Cloverbuds may participate in occasional, non-competitive, age-appropriate activities.

**NOVICE:** Members who are 8 years old AND in the 3rd grade or age 9, 10, or 11 and in the 3rd, 4th or 5th grade.

**JUNIOR:** Members who are 11 years old AND in the 6th grade, 12 or 13 and in the 7th grade.

**SENIOR:** Members who are 13 years old AND in the 8th grade or 14, 15, 16, 17 or 18 years of age.

Youth who are 19 on or by December 31 of the current 4-H year are NOT eligible to enroll as a 4-H member.

4-H Ages are Based on the Member's Age as of January 1, for the current 2021-2022 enrollment year.

Since we have transferred to **4hZsuites**, no 4-H enrollment information will roll over. Every enrollment now has to be entered brand new. **YOU must complete this yourself as a family and Volunteers/Members.**

### **YOU must enroll yourselves**

#### **Mandatory Requirements that have not changed**

- ▶ Members **MUST** submit a current signed medical release/liability form.
- ▶ Adults/Volunteers Must be screened within 5 years and participate in the Working with Minors workshop. Adults, if you have already used **zSuite** to complete the annual working with Minors training, you do not need to create a new account. You can work off your existing account.

## Volunteer Adults/Leaders “Working With Minors” Training **MUST** Be completed each year

Adult Leaders / Volunteers MUST complete the “Working with Minors” module for the 2021-2022 year. To make this process easier, a reset button has been added.

Once you are in his/her/family Zsuite account and have selected his/her profile, follow the steps below:

1. Click on Clover Academy on left menu bar
2. Launch Clover Academy
3. Open NM Working with Minors (even though it says completed)
4. Under 'You have earned a certificate' is a button that says "Reset All Course Progress for the New Year (Cannot be undone)
5. Click on the blue 'Reset All Course Progress for the New Year (Cannot be undone)
6. Start Course

Complete course and a certificate will be available online for you to view with the completion date. If you have completed the training online, the Extension office will be notified of completion date. Leaders/Adult Volunteers—State 4-H mandates that your enrollment will not be approved without the Working with Minor’s Training completed.

Steve and Nicole are willing to have a Working with Minors presentation in your area if requested. Please contact them for more information so that the course can be scheduled.

Remember you will not be able to participate with any of our 4-H youth in any capacity until you have completed all Adult/Volunteer documentation which includes:

- Current Complete Enrollment
- Screening and Application Disclosure completed (required every 5 years) - Check with Extension office to see your last approval date
- Medical Release completed and uploaded into ZSuites
- Working with Minors Completed

## **What to Bring**

Bring personal items, warm clothing, and lots of enthusiasm. See the attached "Items Needed" list. School clothing in good taste will be appropriate. **Bring dressy clothes for the dinner and inspirational words** on Saturday evening (men-nice shirt w/tie and slacks; ladies-nice dress or pants suit, please no prom or formal dresses).

## **Policies**

Senior Leadership Retreat is a unique leadership experience where each delegate demonstrates the personal character for which 4-H is known.

Participate in all Senior Leadership Retreat activities and stay with the group. The program calls for your complete involvement. **Do not** invite friends to visit you.

**No alcohol beverages, drugs, stimulants, vape items of any kind or tobacco in any form be used by participants.**

**Make sure to bring a mask with you. If mandates are still in place in January, masks will be required to wear at all indoor events and activities except during meals.**

No loud music permitted.

Participants are responsible for paying for any damages to the facility. Rooms are inspected by chaperones at check in time and again on the day of departure.

4-H members are NOT permitted to drive to Senior Leadership Retreat.

Youth are required to follow the dress code. If it is not followed, they will be asked to change.

## **Cancellations and Refunds**

Cancellations and refunds are made only if road conditions in the Las Cruces vicinity are severe. Drivers must make their own travel decisions based on road conditions in their area. We do not want anybody taking unnecessary risks in order to attend this event.

Refunds cannot be made unless there is a National Weather Service storm warning in existence in the Las Cruces/Dona Ana area.

If a refund is made due to bad weather, there will be a surcharge deducted to cover actual program expenses incurred up to that point.

If a 4-H'er or adult who is registered cannot attend, a county can substitute another person of the same sex in his or her place, but an actual refund will not be made.

## **Insurance**

The American Life Insurance Company covers all participants for accidents and illness from the time they leave home until their return.

Please report any accidents or illness to a State 4-H Staff member.

Please make sure you have an updated NM 4-H Liability form on file at your County Extension Office. Your agent will need to send a copy of that to the State 4-H Office with the registration information.

### Visitor Commitment

Thank you for visiting New Mexico State University. NMSU shares a global concern with the impact that COVID-19 may have on its employees, customers, visitors, and suppliers who conduct on-site business. **THE REQUIREMENTS WRITTEN HEREIN ARE SUBJECT TO CHANGE AT ANY TIME DUE TO ANIMAL HEALTH ISSUES THAT MAY ARISE**

Before entering any New Mexico county or state fair, all in-state junior livestock (cattle, sheep, goats and swine) to be shown must have application of an approved 2022 NM Youth Exhibitor Fair Tag by an Extension Agent, FFA Advisor or designated Fair personnel and have a New Mexico Livestock Board (NMLB) Form 1 Inspection. NMLB personnel will prepare the Form 1 Inspection for the 2022 Show Season at the time of 2022 Youth Exhibitor Fair Tag application in the project animal. The Form 1 Inspection Form will serve as a form of ownership for the junior livestock exhibitor. Contact Steve if you have any questions.

## NM State 4-H Portfolios

Youth wishing to submit for the trip to Congress will need to have their book compiled and to the County Extension Office in time for them to be mailed to the State 4-H Office with a postmark of **February 1, 2022**.

Books will be evaluated and trips awarded for the 2021 National 4-H Congress. Winners will be recognized by March 1, 2021.

We encourage our Senior 4-H members to submit a State Portfolio. Below is an outline of the acceptable formats. Forms and detailed instructions are available on the State 4-H Website. State 4-H Record Book Outline:

- 1) Must contain a cover page with photo of youth, name, age, club and county
- 2) Must contain a State 4-H Resume as outlined in the 4-H Portfolio Guidelines
- 3) Must be cumulative – showing records for all the years a youth has participated in 4-H.
- 4) This can be done in a variety of ways:
- 5) Layer county record books in a large binder with a divider between each year – include no more than three projects per year (they may have less, but not more) and keep projects consistent across years.
- 6) Utilize the current State 4-H Portfolio format with profiles that summarize your 4-H career in each section and project record sheets for the project profile




